Getting your shipment through customs

If you have elected Heizwerthy as your forwarder to handle your cargo from door to door, our partner office in the country of import or export will ensure the customs clearance is handled according to that country's regulations.

1 SUBMIT A COMPLETED CUSTOMS POWER OF ATTORNEY.

The Power of Attorney allows the Heizwerthy to transact customs business on your behalf. All US Customs brokers are mandated to have a Power of Attorney on file prior to transacting any customs business on behalf of the importer.

2 DETERMINE IF YOU NEED A CUSTOMS BOND.

If you are importing merchandise into the U.S. for commercial purposes that are valued over \$2,500, or a commodity subject to other federal agencies requirements (i.e. firearms or food), you must post a Customs bond to ensure that all duties, taxes and fees owed to the federal government will be paid.

You have the option of obtaining a **single entry** or **continuous bond**. The type of bond you elect to obtain ultimately depends on how often you import into the U.S. For instance, if you only import on occasion, the single entry bond is recommended. If you import frequently (3 or more shipments annually) and through various ports of entry, the continuous bond is beneficial and economically the best choice.

A **continuous bond** covers all of your transactions **INCLUDING** ISF filings for a period of one year. If you opt to obtain a single entry bond for your customs entry, you must also post an ISF bond to file your ISF.

- 3 PROVIDE ISF DETAILS (FOR OCEAN SHIPMENTS ONLY).
 - All ocean shipments into the United States require an ISF filing. Untimely filings can result in a penalty of up to \$10,000.
- PROVIDE DOCUMENTS FOR CUSTOMS CLEARANCE.

Documents Required for General Cargo

Cargo subject to Partner Government Agencies (PGA) such as FDA, FWS, EPA, etc. is not considered "general cargo" and requires additional documentation as regulated by each agency. If you are importing cargo subject to PGA regulations, we will provide assistance in obtaining the proper documentation.

Heizwerthy Payment Terms

For accounting purposes, Heizwerthy has two classifications of customers: *Credit Customers* and *Cash Customers*.

Credit Customers: Customers with an approved credit application on file with credit terms.

Cash Customers: Customers without an established line of credit.

Cash Customers are required to pay for all services in advance via **CargoSprint.com.** Heizwerthy will not perform any work for Cash Customers until all documents and payments have been received.

Credit Customers remit payment according to the terms agreed upon. Payment may be issued by mail or ACH wire.

Paying your Duty, Taxes, and Fees to Customs

It is the responsibility of the importer to ensure U.S. Customs & Border Protection promptly receives payment of duty, taxes, and/or fees assessed on every import transaction. Unless prior authorization has been obtained from CBP, payment is due within 10 days of the release of your shipment.

You have options to make your payment to CBP:

1 - Heizwerthy can pay on your behalf.

We will process your shipment and remit payment to customs on or before the payment deadline electronically. Our fee to advance payment on your behalf is 3% of the total amount due or \$5.00 minimum.

2- You can pay customs directly.

To pay customs directly, you must set up a CBP ACH Debit Account. Once your account has been set up, you will receive a payer unit number. Heizwerthy will need this Payer Unit number prior to clearing your shipment. Customs will deduct the payment directly from your bank account by the 10th day after release. There is no fee to set this up. Complete and submit the ACH application directly to customs to get started.

ACH Debit Process

- Heizwerthy receives Preliminary Statement from CBP of entry summaries scheduled for payment.
- Heizwerthy Transmits ACH Payment Authorization to CBP through ABI.
- · Heizwerthy receives Confirmation Message that the authorization has been accepted.
- After ACH payment authorization is approved, funds transfer begins. CBP transmits payment information to your bank and the Treasury account is credited. Your account is debited usually two business days after CBP accepts the initial payment authorization.

Security Measures

ACH is preferred and secured. There are measures to safeguard the payer's account information and to ensure the correct amount is debited.

- A unique payer unit number is assigned to each payer and is used for all Transactions. CBP does not maintain on-line files of payer bank account information -- all transactions are designated by the payer unit number.
- CBP cannot begin the transfer of funds until Heizwerthy transmits payment authorization.
- Only the broker who originally transmitted the entries to CBP can transmit the payment authorization. An importer's designated broker can use the importer's payer unit number to pay only that importer's statements.
- Payment authorization is not accepted unless the payer's statement total equals the total recorded by ACS for the statement. If they differ, authorization is not accepted and an error message is transmitted to the filer so that the problem can be corrected.

The LiveTrack Portal: Your Virtual Customer Service Kiosk!

Want to see your shipments and know when to expect them? Get connected to the information you want with LiveTrack, our web-based application that shows real-time details of your shipment's progress.

LiveTrack is an interactive online portal and tracking tool that provides 24/7 access to Pickup Orders, Warehouse Receipts, Cargo Releases, Shipments, Sales Orders, Purchase Orders, Jobs, Invoices, and more. You can log in to your account from any Internet-connected computer worldwide at any time!



SECURE ACCESS

LiveTrack is password protected, ensuring that only authorized users have access to shipment and inventory information. Permissions options include setting access per company or per individual. Each customer gets a unique ID number.



REAL-TIME STATUS UPDATES

Want to know if your cargo is in transit? Did it arrive at the destination port yet? Where is the Bill of Lading or Air Waybill? LiveTrack answers all these customer questions for you. Documents are attached and can be viewed and printed at any time.



UPLOAD DOCUMENTS

You can upload your documents online and a Heizwerthy customer service representative will be notified immediately.

Once your documentation has been processed, you will receive a welcome email with your login credentials to LiveTrack.
